# TCR Coordination

## Action 5: systematic implication of RUs in TCR process

- New process has been jointly defined and implemented for the RFC NSM IM to allow a proactive planning and integration of TCRs
- Evaluation of the process in 2020 is difficult because of the complex impacts of the COVID-crisis, however dedication of consulted parties to continue with the agreed process
- RUs are consulted via national consultations process and/or pragmatic meetings

# PCS

## Action 6 : Enhance use of path coordination system (PCS)

- The new system (PCS Envelope) has been deployed
- Breaking many of the technical barriers that existed before

# Border harmonisation process

## Action 7: identify and prioritize cross-border issues

- Communication between TT department

### ➤ ACTION COMPLETED

#### Linking trains

- RNE is working on a solution for linking pair and impair trains. They have ordered a CR where TIS is checking the train numbers at a linking region (difference between two train numbers if the result is 1 – pair/impair case) if those cases are found TIS will link automatically
- /!\ More cooperation with RU is needed to link for the whole TT period as the responsibility is held by Rus
- A "quick win" before the arrival of the Train Id would be for the RUs - who agree - to authorize their IM to send all TCM messages via the common interface to TIS?

# Train tracking and Estimated Time of Arrival

Action 8: Consider the application of the corridor to be one of the RNE pilot for the ETA program (at one corridor border)

- RFC Pilot inspired by the H00 program of SNCF in the axis Lyon Bettembourg + CFL Cargo to improve on time departure
- RNE: TIS data quality project to improve running train monitoring
- Not yet clear vision on information flow to engage ETA project

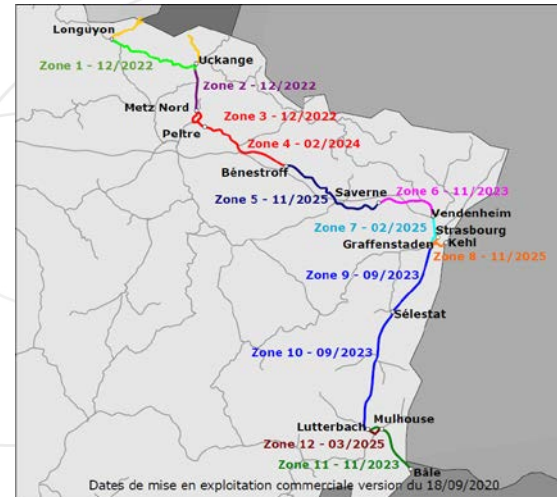

## Action 13: Simplification and digitalization of the CID's

- RNE launched a Digitalisation Task Force to digitalise the Network statements and Corridor information Documents
- After a tendering process, DevCraft has been selected as provider. The tool NCI (Network and Corridor Information) is now in testing phase by the Task Force
- Launch of the tool will be at the publication of the CID's TT 2022
